RESOLUTION OF THE BOARD OF DIRECTORS OF GOLDEN ARROW BUS SERVICES (PTY) LTD ("COMPANY") PROPOSED AND PASSED ON 2 JULY 2020

Resolution: 2020-09

NOTED:

That the Company lodged an exemption application with the South African Road Passenger Bargaining Council ("SARPBAC") in respect of the main collective agreement concluded in May 2018 for the periods 2018/2019 and 2019/2020.

The exemption application was unsuccessful and the Company subsequently lodged an exemption appeal with SARPBAC. The said appeal was also unsuccessful.

The Company made an application to the Labour Court on 16 November 2018 to review the exemption appeal ruling. The exemption appeal ruling was reviewed and set aside by the Labour Court, and the exemption appeal was remitted back to SARPBAC for rehearing. The remitted exemption appeal was re-heard and was yet again unsuccessful.

The Company made another application to the Labour Court at the end of May 2019 (under case number C351/2019) to review the second exemption appeal ruling. The second exemption appeal ruling was reviewed and set aside by the Labour Court in a judgment dated 17 October 2019, but the exemption appeal was again remitted back to SARPBAC for rehearing. The Company applied for and was recently (on 9 June 2020) granted leave to appeal against the remittal of the matter back to SARPBAC for rehearing. A notice of appeal to the Labour Appeal Court was recently delivered on behalf of the Company and this appeal needs to be prosecuted.

RESOLVED:

- THAT the Company prosecute the appeal to the Labour Appeal Court in respect of the Labour Court's judgment under case number C351/2019.
- 2. THAT Edward Nathan Sonnenbergs Inc. ("ENSafrica") be and are appointed as attorneys for the Company for the purposes of the abovementioned proceedings.
- 3. THAT John Dammert, the Company's Human Resources and Corporate Affairs Executive is authorised to provide a power of attorney on behalf of the Company authorising ENSafrica to prosecute the abovementioned appeal on the Company's behalf, and he and such other persons as are nominated by him ("Designated Representatives") are authorised to do all such things and to sign all such documents on behalf of the Company as are necessary to enable the proceedings as
